COMPANY DOCUMENTS

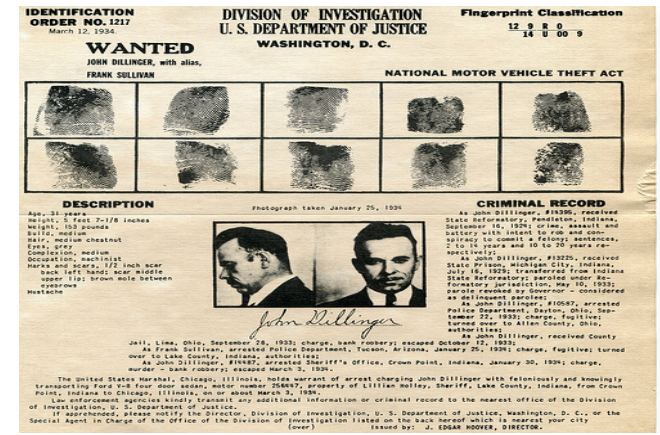

Then it could be useful to retrieve personal and very confidential information about a person.

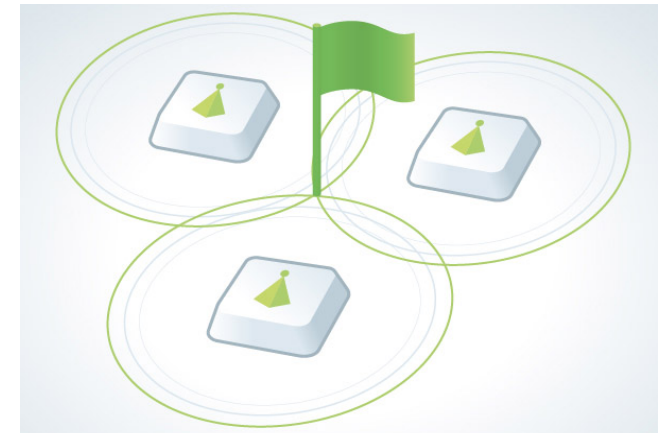
Pieces of information like family members, paternity and maternity, joint ownership of property or even the photo of the person in whom you are interested could be useful.
